HOA Meeting Minutes December 8, 2022

Approval of the Minutes: The amended November 10th minutes, which included the unanimous approval of \$1,050 for annual blockworker gifts, were approved unanimously.

Treasurer's Report: Report was submitted prior to the meeting by Mark Meihaus. The Board reviewed the monthly income, expenses, and balances for November, 2022. A motion was made and passed unanimously by the Board to approve the November 2022 report as submitted. The Board reviewed the annual budget, discussing the following:

- Agreed to reduce allocated funds for Dumpster Day, reflecting the projected cost of a central pick-up location. The Board will consider seeking sponsorships to offset the cost for this event.
- Allocated \$3,000 for move nights and an additional \$1,000 for special events.
- Potentially charging for the realtor letters (HOA info to buyers), to increase revenue and offset related costs. Brandon will research and report at an upcoming meeting.
- The Board unanimously approved continuing the current attorney service agreement with the hourly rate fee structure.

Dues Report: Presently 347 (45.7%) of the households have paid their annual CKS/E HOA dues compared to 365 (48%) last year.

Special Events: Megan James provided updates regarding:

- December 18th Winter Festival (Laurel Park) Time changed to 1:30-3:30, to accommodate Santa's schedule. Marketing has been updated to note the time change.
- Will need to start planning in early 2023 for the movie nights to be scheduled
- Halloween decorating contest awards are forthcoming.

Covenant Violation Updates: In process. Nick reported that all the all violations in the queue have been reviewed. There are 37 open violations, 7 of which are new. The resolution process is starting over for some of the violations, due to timing.
